

## Harlem Avenue between 63rd and 65th

CAG Meeting #3 Summary | December 1, 2017



The third Community Advisory Group (CAG) meeting for IL 43 between 63<sup>rd</sup> Street and 65<sup>th</sup> Street was held on Friday, December 1, 2017 at the Bedford Park Public Library at 7816 W 65<sup>th</sup> Pl, Summit, IL 60501 from 10:00 a.m. – 12:00 p.m.

To announce the third CAG meeting, an email invitation and postcards were sent to the members of the CAG and local, state, and federal representatives. Twenty-one CAG members attended the meeting.

## The meeting included:



A binder

including exercise workbook and comment sheet.



A PowerPoint presentation

recapping public involvement to date, highlighting the Purpose and Need statement, and evaluating alternatives.



A discussion and exercise

to review and evaluate alternatives.





### **Facilitated Discussion and Group Exercises**

The second half of the meeting focused on presenting seventeen alternatives categorized into the following six groups:

- Minor Build
- Belt Railway Company of Chicago (BRC) Elevated / Depressed
- 63rd St. Elevated

- 63rd St. Depressed
- 65th St. Elevated
- 65<sup>th</sup> St. Depressed.



The CAG facilitator explained the proposed solutions and described the differences between the alternatives. Each CAG member was given time to comment and mark which alternative they would like to see carried forward, and provided additional criteria to evaluate and measure the alternatives.

#### Based on the comments received, the CAG feels:

The Minor Build should be dismissed as it does not improve traffic or other issues previously identified.

The BRC Elevated / Depressed seems to be the most effective at solving train blockage, but is too costly.

63<sup>rd</sup> St. Elevated and 63<sup>rd</sup> St. Depressed create free flow of traffic with changes to jughandle and proposed ramps.

The roundabout option for 65<sup>th</sup> St. Elevated could be beneficial for traffic flow, but seems confusing and can cause issues with trucks.

# Other alternatives the CAG would like to see:

- 63<sup>rd</sup> St. Elevated with Ramps and 65<sup>th</sup> St. Elevated with Ramps or Roundabout
- 63<sup>rd</sup> St. Elevated Intersection and 65<sup>th</sup> St. Elevated Intersection
- 63rd St. and 65th St. under BRC
- 63<sup>rd</sup> St. Depressed Intersection and 65<sup>th</sup> St. Depressed Intersection

Overall, the CAG expressed concern with impacts to property access on all alternatives and noted drainage and utility issues for BRC Depressed, 63<sup>rd</sup> St. Depressed, and 65<sup>th</sup> St. Depressed.

## **Next steps**

The Project Study Group (PSG) will review and consider the input from each CAG member when refining alternatives and developing combined alternatives, which will be presented at the fourth CAG meeting.

The fourth CAG meeting is anticipated to take place Spring 2018.
